

SYCAMORE RANCH CAMPGROUND AND DAY USE AREA

CAMPSITES are issued on a first come, first serve basis at **\$20.00** per night. No reservations will be accepted for individual campsites. Payments are to be made in the provided envelopes and deposited in the box accordingly. Placards shall be placed in view on the vehicle's dashboard, visor or mirror so that the caretaker can verify payment.

GROUP RESERVATIONS can be made for Group Sites A and B at 915 8th Street, Suite 125, Marysville, CA 95901 at **\$200** per night.

CHECK IN TIME is **2:00 PM**. All camping fees must be paid in advance.

CHECK OUT TIME is **12:00 PM**. No person shall camp for more than seven (7) days in any thirty (30) day period.

WATER & SEWER: There cannot be any draining of gray water or sewage in the park. There is an RV dump station inside the front entrance of the park. Use of the dump station is free for overnight campers. No portable holding tanks are to be dumped at restrooms.

SPEED LIMITS: Please drive slowly and carefully within the park. The speed limit is **5 MPH**.

TRASH AND CONTAINERS: Littering is prohibited. Please dispose of all household trash in the dumpsters and not the fire pits. Household type trash only please. Please use designated recycle containers as available.

GENERAL HOUSEKEEPING: No hanging of laundry from trees or tying anything to trees. Please keep your space clean, orderly and free from debris.

NOISE LEVELS shall be kept low enough during the day to not create a nuisance to other park users. Amplified music or broadcasts of any kind are prohibited without a permit.

QUIET HOURS are from **10:00 PM** to **7:00 AM**. During these hours, no person shall make, either verbally or mechanically, any excessive noise.

FIRES are permitted only in barbeque areas, fire pits, campfire rings or posted clear areas. The County shall have authority to prohibit burning at any time if the danger of wildfire becomes elevated as determined in the County's sole discretion.

PETS: Your pets are welcome with you at all times. Pets must be leashed and under the complete control of the pet's owner. Leashes shall not be more than eight (8') feet in length. It is the responsibility of any person who owns or has charge, care, control or custody of any animal, while in Sycamore Ranch, to clean up fecal matter from their animal promptly.

FIREARMS: No firearms, fireworks, BB guns, pellet guns, bow and arrows, paint ball guns or slingshots are permitted at any time.

VEHICLES: Operation of Off-Road Vehicles or ATV's are prohibited. Vehicles must be driven only on marked roads or in designated parking areas and shall at no time be permitted to enter or cross any body of water.

VIOLATIONS of these rules will be subject to prosecution pursuant to Yuba County Ordinance Code 8.79 and may be subject to 6 months of jail time or result in a fine of up to \$1,000.
