**Veterans' Preference Points**

**Purpose:**

The purpose of this Policy is to demonstrate the County of Yuba's support and recognition of our Country's service men and women by allowing them, or their widows as indicated, preference points in the establishment of Eligible Lists in the employment selection process.

**Policy:**

This Policy shall apply to original entrance selection procedures for all persons who become eligible for certification for Eligible Lists as indicated in Merit Resolution 2002-21 (dated 5/5/05) Article 9, Section 1. Those who have served on active duty for a period of not less than ninety (90) days in the armed forces in time of war or national emergency, or in time of peace in a campaign or expedition for service in which a medal has been authorized by the government of the United States, and who has been discharged or released under honorable conditions, and the widows of such persons, will be allowed one of the following additional credits.

| All other Veterans and Widows of Veterans | 5 points  |

**Procedure:**

Proof of military service, such as a DD214, by which an eligible veteran is entitled to claim the allowance of additional credits, shall be furnished to the Personnel Director.

For the purpose of this Policy, "disabled veteran" means any veteran as defined herein who is currently declared by the United States Veterans Administration to be 20% or more disabled as a result of his or her service. Proof of such disability, provided by the applicant, shall be deemed conclusive if it is on record in the United States Veterans Administration.




