1. Are bidders allowed to include a pricing schedule in addition to or in lieu of Exhibit D (the price proposal sheet)?

**Yes; you may include a pricing schedule in addition to Exhibit D.**

2. Will the County consider extending the bid response deadline by one week to May 19, 2017? Since the County H&HS Department requires hard copies we will have to put our bid in the mail Wednesday May 10<sup>th</sup> in order for it to arrive on time. This gives us very little time to address the answers to our questions.

**Yes; the request for quote has been extended to May 19<sup>th</sup>.**

3. Regarding the 24 hour turn-around time for results, please verify that this is for screen results only. Will the County consider allowing an additional 24-72 hours for confirmation of positive specimens or for specialty tests that use GC-MS or LC-MS/MS as the test methodology?

**Yes the 24 hour turn-around time is only for screen results; 48 hours for screening and 72 hours for GC-MS or LC-MS/MS.**

4. Regarding the sending of results, will the County accept email notification of results with subsequent logging onto a secure website to review results as opposed to result information directly in an email (which could conflict with HIPAA)?

**Yes that would be fine provided results are transmitted through secure website.**

5. On Exhibit D, the County has included in the top portion a section to mark which drugs are available for standard panels. If a vendor can do any of these drugs in urine but not in oral fluid, how should this be marked?

**Any clear indication would be acceptable to include U for urine and/or O for oral.**

6. Regarding the EtG test, does the County want this priced for only a screen, or for a screen with automatic confirmation (bundled price)?

**Screen with automatic confirmation.**

7. Regarding In-Court Testimony, is this to be priced per hour or per day? Would the County allow for this item to include a per-hour price as well as travel fees (transportation, lodging, per diem) not to exceed County rates?

**Per day + travel at county per diem rates.**

8. Regarding the "Cassette Substance Abuse Test Device," does the County have a specific number of drugs required for this item? Or can this item be removed?

**This can be removed.**

9. Regarding the contract template 2013 page 9, Section D.4 INDEMNITY – will the County allow for the addition of the following language: “...agents, and employees from any *third-party* liability for damage or claims...”?

**This will be part of the contract negotiations with the winning bidder.**

10. Regarding the contract template 2013 page 9, Section D.4 INDEMNITY - will the County allow for the following modifications to be made to the language: "...pertain to, or relate to the *gross* negligence, ~~recklessness~~, or willful misconduct of CONTRACTOR, which may arise from the intentional ~~negligent~~ acts or omissions of CONTRACTOR...”?

**This will be part of the contract negotiations with the winning bidder.**

11. Regarding the contract template 2013 page 9, Section D.4 INDEMNITY - will the county add the following language to the paragraph: "*Despite the above, in no event shall contractor be obligated to indemnify defend and save harmless the County, their officers, agents and employees to the extent that any action claim or loss occurs or results, in whole or in part, from the acts or omissions of the County, their officers, agents and employees or third parties.*"?

**This will be part of the contract negotiations with the winning bidder.**

12. Regarding the contract template 2013 page 9, Section D.7 PERSONNEL - will the County replace the segment that reads: "...CONTRACTOR shall remove any such person immediately upon receiving written notice from COUNTY of its desire for removal of such person or persons." with "*County shall inform Contractor in writing of the desire to remove such personnel with the reasoning for said removal, Contractor shall use its reasonable judgment to comply with County's request.*"?

**This will be part of the contract negotiations with the winning bidder.**

13. Regarding the contract template 2013 page 10, Section D.11.3 - will the County strike the word "reasonable" in the first line? The prices for the services rendered are reasonable, so actual value for the services rendered shall be paid upon termination.

**This will be part of the contract negotiations with the winning bidder.**

14. Is there an RFQ number to reference?

**No**

15. The lab tests - are they screens only or is confirmation testing needed as well?

**Confirmation testing needed as well.**

16. If confirmation testing is needed, are non-negative screens to be automatically confirmed, or will confirmation testing only occur if Yuba HHSD official orders it?

**By HHSD order.**

17. For lab test results, will Yuba HHSD accept screen only results within 24 hours, and confirmation testing results (if required) within 48 hours?

**Yes; 48 hours for screening and 72 hours for GC-MS or LC-MS/MS.**

18. Do Yuba HHSD employees perform their own urine and oral fluid collections? Or do you need the Vendor to quote collection services as well as lab testing?

**HHSD employees perform their own.**

19. If you require collection services, please advise what locations collection services need to be in (what cities).

**Marysville, California; currently using Fed Ex.**

20. Who is your current vendor for these services?

**This information is public record; Redwood Toxicology Laboratory**

21. What is your current pricing for all items on Exhibit D Price Proposal?

**This information is public record; attached is an excerpt from the contract.**

22. What is the anticipated award date?

**We anticipate an award date of July 1, 2017**
