

**COUNTY OF YUBA**  
**REQUEST FOR PROPOSALS TO PROVIDE LEGAL REPRESENTATION**  
**FOR INDIGENT CRIMINAL DEFENDANTS**

You are invited to submit a proposal for the purpose of providing legal representation for indigent criminal defendants in Yuba County. While the Public Defender provides legal representation for criminal defendants in the County of Yuba, additional defense counsel is necessary to provide legal representation when a conflict arises or in multiple defendant cases. The County of Yuba is seeking an attorney to represent criminal defendants where a "first conflict" arises.

The attorney selected shall agree to accept representation in connection with police identification and/or pre-statement counseling and all cases assigned by the court including murder cases. Murder cases will be limited to a maximum of two (2) new cases per contract year and will be handled through completion. Legal representation for all cases will terminate when the indigent defendant is sentenced in his/her criminal case.

Interested parties responding to this request for proposal need to, at a minimum:

- Be licensed and in good standing to practice law in the State of California and have at least five (5) years of criminal trial experience. The proposal should address applicant's relevant education and experience.
- Maintain an office in the County of Yuba, within a reasonable distance from the Yuba County Courthouse. The office must have sufficient secretarial staff to assure clients have a reasonable opportunity for telephone contact.
- Identify by case name, case number and county, the three most complex criminal court trials, in which the attorney served as the prosecutor or defense counsel.
- Submit the names of three (3) references. These references shall be substantially involved in criminal law and familiar with the attorney's work.
- Submit a detailed transition plan for current pending cases.
- Be able to procure and maintain professional negligence insurance in a form and amount acceptable to the County of Yuba.
- Submit a fee proposal.
- Be willing to enter into a written agreement reflecting a three (3) year term of engagement ending October 31, 2014.
- Provide paralegal, secretarial, interpretive and translation services, as required.
- Provide investigative services, as required.
- Provide expert consulting services, as required.

The contract, if any, will be awarded to the interested party whose proposal is considered to be in the best interest of the County of Yuba. The interested party's capability to provide competent legal representation, business integrity and reliability (in part established through review with provided references), and a total annual fee will be

considered in selecting proposal which is deemed to be in the best interest of the County.

This solicitation does not constitute a contract, offer of employment or offer of purchase.

The cost of preparation of a proposal is the obligation of the interested party. Yuba County will not be liable for any costs incurred by the interested party in preparing or submitting a proposal. The County makes no representation that any contract will be awarded to any respondent to this solicitation. The County reserves the right to withdraw or cancel the solicitation at any time without prior notice. The County also reserves the right to reject any and all proposals at its sole discretion.
